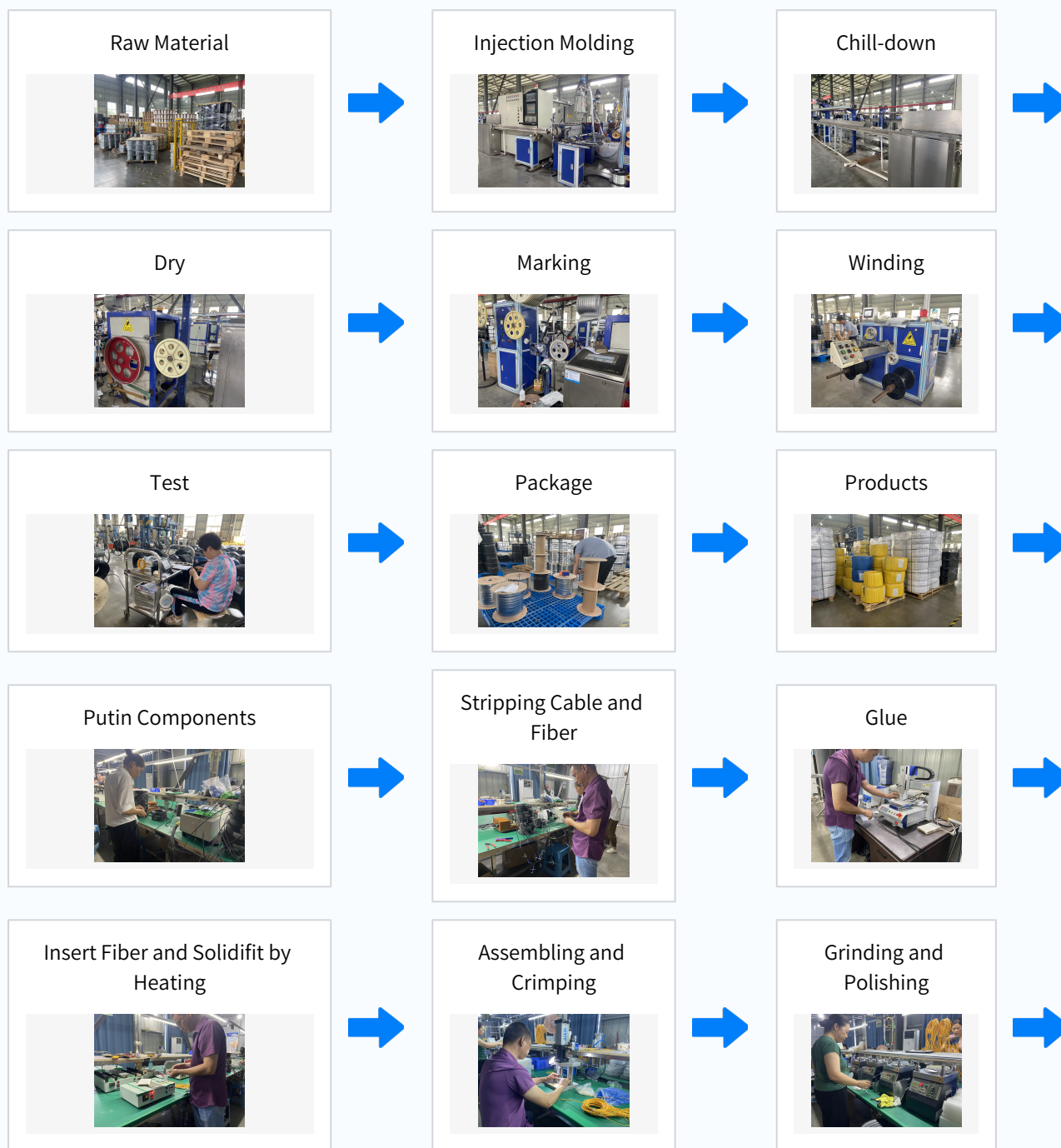

Production Workflow Chart :

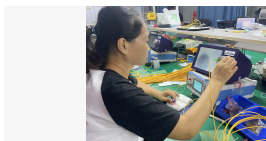
